# Now that I am a Chamber member, how do I get involved?

**After Five Mixers** are networking mixers that are usually planned on the 1st, and 2nd Thursday of each month. Mixers are held at different Chamber member locations each month. Fun, food and adult beverages will be available. The cost to sponsor a Chamber After Hours Mixer is \$400.00.

**Ambassadors** are the heart of the Flower Mound Chamber. They are the group that commits to attending most ribbon cuttings and grand openings. They will also be greeters at many events. Ambassadors are needed for ribbon cuttings typically on Tuesday mornings.

**Annual Banquet** is our annual awards banquet that is held in February of each year. In the past years, the attendance for this banquet has averaged 200 guests.

**Board Room** The Chamber gladly offers you the opportunity to use our Board room in the event that you need a place to meet with a client. We ask that you call and reserve the board room. Note: It will only be available during Chamber hours, M-F 9:00a – 5:00p.

**eNews!** is the best way to stay connected. The Chamber emails an eNews! newsletter each week to keep you informed on all that is going on at the Chamber. The eNews! is our way of keeping in close contact with our members and to make sure that you don't miss anything that is offered. **Member Happenings:** each member may advertise an event or special offer 4 times a year in our eNews! at no charge.

**Fiesta Flower Mound** is our biggest event of the year. It is a community Party with Live and Silent Auctions held at the Embassy Suites. This year's event was our most successful Fiesta ever, with "sold out" attendance of over 600 local citizens and Chamber members.

**Golf Classic Tournament** is held at a local golf club in the spring of each year. Over the past several years our Golf Classic has averaged over 140 golfers. The 2017 Golf Classic was our most successful tournament with 100% sponsorships sold and 100% player spots sold.

**Job Connect** Members may advertise available positions in our weekly eNews! at no charge.

**Leadercast Leadership Seminar** is an annual day long simulcast featuring world renown leadership experts. Usually held the first week of May, you will not want to miss this event! Join us to improve and enhance your business life and personal life.

**Leadership Flower Mound** is a nine-month program that begins in September with a team-building course at nearby Stoney Ranch and ends in May with a graduation of the participants. Examples of classes include: The History of Flower Mound, Education, Community Service, Town, County and State Government. The class meets each month on the second Tuesday from 10:00 – 4:00 p.m.

**Leads Networking** According to Webster's, networking is "to interact or engage in informal communication with others for mutual assistance or support." Leads Networking meets the 2nd and 4th Tuesday of each month at 2001 Lakeside Parkway in Flower Mound. Breakfast is included in the \$5 cost.
